COMMONLY ASKED QUESTIONS ABOUT CHILDCARE SUMMER DAY CAMP

Q: What are the times and dates for the Day Camp?

A: Wooster Camp is June 1 – August 14th 6:30 am – 6:00 pm, Orrville Camp is June 2nd – August 14th 6:30 am – 6:00 pm, Cornerstone Camp is June 1st– July 31st 7:30 am – 4:00 pm, and Waynedale Camp is June 1st – July 31st 7:00 am – 5:30 pm.

Q: What types of activities will take place at camp?

A: Campers will get to go swimming about 2 times a week, tumble at the Gymnastics Center, make art projects with Wayne Center for the arts, complete STEAM activities, take other various field trips to the library, ice cream shop, and parks, and build social emotional skills through relationship building.

Q: How much is camp and how do you take payments?

A: Y Day camp is \$140 for 4–5 days for members and \$160 for 4–5 days for non members, and \$110 for 1–3 days for members and \$120 for 1–3 days for non members. Summer Camp at Cornerstone is \$10 a week and you must be on free and reduced lunch to be eligible and have an ODJFS Denial letter. Payments are charged the Friday BEFORE the week of camp. A credit card must be on file to enroll.

Q: Is there a registration fee?

A: Yes, the registration fee for all day camps is \$10, please talk to the Child Care Director if you receive ODJFS.

Q: Do we need a pool pass?

A: All campers at the Wooster Camps must have a Y membership, or a pool pass to attend camp. The Orrville YMCA Camp kids do not need a pool pass to swim at the Y.

Q: What should my camper bring?

A: See List Below: Campers should bring swimsuits and towels with their name written on the tag EVERY day. Campers should also be dressed for the weather in PLAY clothes, we will get messy and sweaty. Water bottle, set of extra clothes, tennis shoes (children will not be allowed to do certain activities unless they are wearing tennis shoes)

CONSENT, RELEASE AND WAIVER OF LIABILITY
ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT**

DESCRIPTION AND LOCATION OF EVENT(S)

IN CONSIDERATION of my being permitted to participate in any way in the activities ("Activities") at the YMCA of Wooster (the "Y"), I agree as follows:

1. I know the nature of the Activities to be held and by the Y. I will inspect the premises, facilities, and equipment to be used. IF I BELIEVE ANYTHING IS UNSAFE, I WILL IMMEDIATELY LEAVE THE AREA AND REFUSE TO PARTICIPATE FURTHER IN THE ACTIVITIES.
2. I FULLY UNDERSTAND that: (a) THE ACTIVITIES may be DANGEROUS and participation in the Activities involves RISKS AND DANGERS that include SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in the Activities, the rules and regulations of the Activities or the Y and, the condition and layout of the premises and equipment; (c) there may be OTHER RISKS NOT KNOWN TO ME or that are not readily foreseeable at this time; (d) THE SOCIAL AND ECONOMIC LOSSES and/or damages that could result from these Risk(s) COULD BE SEVERE AND COULD CAUSE PERMANENT DAMAGE OR DEATH.
3. In exchange for being able to participate in the Activities, I HEREBY ACCEPT AND ASSUME ALL SUCH RISKS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR THE LOSSES, COSTS, AND/OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS, OR DEATH, EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW.
4. I HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE the Y, its officers, employees, and Board Members, the, the promoters, participants, sponsors, advertisers, premises or event inspectors, underwriters, consultants, and other persons or entities who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or Activities, and each of them, their directors, officers, agents, employees, representatives, owners, members, affiliates, successors, and assigns, all, for the purposes herein, referred to as "Releasees" FROM ALL LIABILITY TO ME, my personal representatives, assigns, heirs, and next of kin, FOR ANY AND ALL CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON ACCOUNT OF ANY INJURY TO ME, including, but not limited to, death or damages to property, CAUSED OR ALLEGED TO BE CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE.
5. If, despite this release, I or anyone on the my behalf, makes a claim against any of the "Releasees" named above, I AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS THE RELEASEES and each of them from ANY LITIGATION EXPENSES, ATTORNEY FEES, LOSS, LIABILITY, DAMAGE, OR COST THEY MAY INCUR DUE TO THE CLAIM MADE AGAINST ANY OF THE "RELEASEES" NAMED ABOVE, WHETHER THE CLAIM IS BASED ON THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
6. I sign this agreement on my own behalf.

I HAVE READ THIS CONSENT, RELEASE, AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, UNDERSTAND THAT BY SIGNING IT I GIVE UP SUBSTANTIAL RIGHTS I WOULD OTHERWISE HAVE TO RECOVER DAMAGES FOR LOSSES OCCASIONED BY THE RELEASEES' FAULT, AND SIGN IT VOLUNTARILY AND WITHOUT INDUCEMENT AND PRESENT I HAVE THE AUTHORITY TO SIGN THE SAME.
